Fire Prevention:

Written report presented. Lt. Chris Moeller attended Fire Inspector I class

the week of February 17th. Fire inspections are being assigned and will begin April 1st. Fire Prevention Open House is scheduled for September

26th. In discussions with Village Woods to plan an evacuation drill later this year.

Assistant Chief:

Written report submitted. The Kurtz contract is now down two members. A Kurtz meeting is scheduled with the supervisors of CTFPD's account representative to discuss the issue regarding new applicants. One new POC member has completed the hiring process. Firefighter/Paramedic Allred has moved from the full-time Kurtz contract to part-time with Kurtz and CTFPD. Standard Operating Guidelines for the Mobile Data Terminals and the Diesel Exhaust System have been completed. Andres Medical and Fire Recovery billing are current.

Chief's Report:

Written report was presented. Working with Cheryl Albrecht on a grant program through Country Financial. CTFPD is able to obtain \$750.00 and will be asking for a Reveal Fire PRO handheld thermal imaging camera. Station #41 is being utilized by local police K9 units for training and Prairie State College for the Firefighter Academy. Half of the lighting at Station #41 has been changed over to LED.

Approval of Bills:

Communications:

Steger Fire Department – Thank You - A thank you was received from Steger Fire Department for responding to a fire at 3750 Stella Blvd. on February 18th.

Crete Fire Department – Thank You - A thank you was received from Crete Fire Department for allowing them to utilize a CTFPD engine while Crete's engine was out of service.

Old Business:

Discuss Providing Emergency Services Coverage to Steger Estates – Trustee Miller stated he presented Steger Estates with a list of questions to get a better understanding of exactly what they are looking for in regards to CTFPD providing coverage. CTFPD is waiting on a response.

New Business:

Letter of Resignation – Anthony Lopez – Motion to accept the letter of resignation from Anthony Lopez by Trustee Miller. Second Trustee Rosandich. Motion carried. (2-yes, 0-no, 1-absent)

Discuss / Approve Renewal of Insurance – Corkill Insurance – Chief Panega presented Trustees with a proposal from Corkill Insurance regarding the annual renewal for insurance. There was a premium increase of approximately \$1,800.00. A large amount of the increase is due to the additional coverage for Sexual Abuse & Molestation. CTFPD's agent has recommended dropping this additional coverage, which is intended more for churches, schools, clubs and day care centers. Discussion was had.

Trustees agreed a decision will be made at the April District Meeting after they have time to review the proposal.

Adopt Changes to Rules & Regulations – Organization Chart – Chief Panega proposed a change to the Rules & Regulations Organization Chart by creating the position of Deputy Chief. The Deputy Chief would rank above the Assistant Chief and the Assistant Chief would answer to the Deputy Chief. The salary for both the Deputy and Assistant Chiefs would be the same. Motion to adopt the change to the Rules & Regulations – Organization Chart to create the position of Deputy Chief by Trustee Miller. Second Trustee Rosandich. Motion carried. (2-yes, 0-no, 1-absent)
