## MINUTES FROM THE JANUARY 2021 CTFPD TRUSTEES' MEETING

Secretary's Report: Motion was made by Trustee Miller to accept the minutes of the December

14, 2020 meeting. Second Trustee Peterlin. Motion carried. (3-yes, 0-no)

Treasurer's Report: Treasurer's Report was read by Trustee Peterlin. Motion to accept the

Treasurer's Report by Trustee Miller. Second Trustee Zimmerman. Motion

carried. (3-yes, 0-no)

Fire Call Report: Written report presented - 135 calls were reported for the month of

December; 1,338 calls for the year 2020.

**EMS Report:** Written report presented. Safety lane inspections were completed on all three

ambulances.

Training Officer: Written report submitted. Members listed are working on completing

outstanding trainings. Tuesday night trainings will resume tomorrow.

Grant Summary: Written report presented. Working on the OSFM Grant for four portable

radios and the AFG Grant for an engine replacement.

Fire Prevention: Written report submitted. Construction continues on both solar farms on

Goodenow Road. The renovation of New Hope Center is ongoing.

**Deputy Chief:** Written report submitted. The Kurtz contract is at full staffing. One new part

time member is completing training. Inspections have been suspended due to

Covid. All ISO testing is complete for 2020. Accident and ambulance

billing are current. All NIFRS reporting is on hold until further notice due to issues with a new software installation.

#### Chief's Report:

Written report was presented. The new support vehicle is in service as of today. Discussion was had whether to keep the used Explorer as an additional Chief's vehicle, rotating between the Deputy and Assistant Chiefs. Two new AED's for the front-line engines and new lifting devices to prevent back injuries will be purchased with the IPRF Grant, which is a little over \$8,000.00. Firefighter/Paramedic Ed Wilson was recognized for ten years of service. There is another leak in the lower roof at Station #43 which will be patched when the weather allows. Plans are to go out to bid for roof replacement next fiscal year. CTFPD continues to support Illinois Partners in Hope, Free Feed Pop UP Volunteers and the Southland Voice by distributing food out of Station #41.

**Approval of Bills:** 

Motion to accept bills as submitted by Trustee Miller. Second Trustee Zimmerman. Motion carried. (3-yes, 0-no)

Communications:

Chuck and Debbie Lane – Thank You – A thank you was received from Chuck and Debbie Lane for service provided by CTFPD members.

**Old Business:** 

Open & Discuss/Award "Engine #43 Refurb" Bid – Station #43 – Only one bid was received. Trustee Zimmerman opened and read into record the following bid received for the Refurb of Engine #43 Alexis/HME Pumper:

- 1) Alexis Fire Equipment Co., Alexis, IL
  - \$224,987.00 Refurb w/ Frame Rail Replacement
  - \$ 1,425.00 Option for LED Headlights
  - \$ 1,525.00 Option for Cascade System Module
  - \$ 3,088.00 Option for LED Lights

After much discussion, Trustee Miller made a motion to award the bid for the Refurb of Engine #43 to Alexis Fire Equipment Co. in the amount of \$224,987.00, plus the Cascade System Module for \$1,525.00 and the LED Lights for \$3,088.00, with the condition the bid is approved by the Committee after review. Second Trustee Zimmerman. Motion carried. (3-yes, 0-no)

**New Business:** 

**Discuss Renewal of Kurtz/AMR Contract** – Chief Panega requested the District hold off on discussion of the Kurtz/AMR Contract renewal at this time.

Approve \$21,800.00 Grant – Firehouse Subs Public Safety Foundation Board of Directors – CTFPD has received a \$21,800.00 grant from Firehouse Subs. The grant will be utilized for the purchase of rescue tools for one of the front-line engines. It is recommended the grant be accepted by a motion from the Board of Trustees. Motion to approve the Grant of

\$21,800.00 from Firehouse Subs Public Safety Foundation by Trustee Miller. Second Trustee Peterlin. Motion carried. (3-yes, 0-no)

**Sealing of Closed Session Minutes** - Discussion was had whether to open any closed session minutes to the public. Trustee Miller made a motion to keep the closed session minutes sealed another six months. Second Trustee Zimmerman. Motion carried. (3-yes, 0-no)

Misc. Items – An application has been filed for property tax exemption on four parcels purchased by the Will County Forest Preserve.

Chief Panega attended a virtual meeting to discuss the detour for the stoplight installation at Exchange Street and State Line Road.

Discussion is being had to improve the intersection at Burville Road and Exchange Street.

CTFPD is running into issues with accounts payable checks not being delivered on time/lost in the mail. Chief Panega questioned if CTFPD should consider electronic payments to vendors. Trustees directed Chief Panega to gather information on electronic payment options for discussion at a later date.
