Fire Call Report: Written report presented - 105 calls were reported for the month of January.

EMS Report: Written report presented. AMR has offered free training for members;

additional details are being gathered.

Training Officer: Written report submitted. Members listed are working on completing

outstanding trainings.

Grant Summary: Written report presented. The OSFM Small Tool, Firehouse Subs and

ComEd Grants have been submitted. Work continues on the AFG Grant for

an engine replacement.

Fire Prevention: Written report submitted. Multiple fire alarm and sprinkler system

inspections have been filed.

Deputy Chief: Written report submitted. The Kurtz contract is at full staffing. CTFPD

continues to advertise for POC membership on the signs and social media. ISO testing will be scheduled for 2021. Accident and ambulance billing are current. Intentions are to have the installation of mobile data units in the support vehicles completed by spring. Officers have discussed creating a

SOG regarding extra manning for the station during heavy snow. A spreadsheet was presented comparing the number of multiple incidents, the type of incident, mutual aid calls and the a.m. versus p.m. shifts for over five years. Discussion was had regarding the increase in calls requiring crews to go out of town to assist surrounding communities and what options there are if one of the crews responds mutual aid to a neighboring community followed by CTFPD incurring multiple calls requiring additional assistance. A recommendation was made by Deputy Chief Radtke to form a committee to plan how the District will handle this growing issue in the next five to ten years.

Chief's Report:

Written report was presented. Support vehicle #UT43 is in the parking lot of Station #42 with a for sale sign and a notice was placed in the paper. Bids will be opened at the March 8th District Meeting. An estimate of \$4,900.00 was received for damage to the plow truck during the last heavy snowfall. A claim will be filed with insurance for repairs unless the damage is found to not be as extensive once work has begun. CTFPD continues to meet with Will County on the distribution of COVID-19 vaccinations.
