Old Business:

Open & Discuss/Award "2008 Ford Explorer" Bid – Trustee Zimmerman opened and read into record the following bids received for the Sale of the 2008 Ford Explorer.

Grant Summary: Written report presented. The OSFM Small Tool Grant has been submitted

for portable radios and the AFG Grant was submitted for an engine

replacement.

Fire Prevention: Written report submitted. Construction on the two solar fields and the

renovation of New Hope Center continues.

Deputy Chief: Written report submitted. A bi-annual meeting was held with the Kurtz staff

regarding department operations and expectations. Firefighter/Paramedic Allred resigned from his part-time position with the department. CTFPD continues to advertise for POC membership. ISO testing will be scheduled for 2021. Accident and ambulance billing are current. Unit #E41 had an issue with the computer that runs the transmission. Parts were located and

the vehicle was repaired within 24 hours.

Chief's Report: Written report was presented. Interest rates on the bank accounts have

dropped significantly due to the Covid-19 pandemic. Covid-19 cases within the District have declined. Trustee Miller questioned if any information had been gathered on electronic payments for accounts payable. Chief Panega and Secretary Claus explained the options/procedures for electronic payments obtained from the bank. After speaking to Beckett Accounting, concerns were raised regarding the checks & balances of money released from the account by one person and the lack of two trustee's signatures on District checks. The option for automatic withdrawal on utility bills could be

considered.

Discuss / Approve Lawn Maintenance Proposal for the 2021 & 2022 Season – Roy Erikson Outdoor Maintenance Inc. - Roy Erikson Outdoor Maintenance Inc. presented a contract to continue CTFPD's lawn maintenance at all three stations for the upcoming 2021 and 2022 season, which includes a \$50/month increase in price. Chief Panega stated he has been pleased with the work performed by Roy Erikson and has no issue with continuing to use the current company.
