**Fire Call Report:** Written report presented - 143 calls were reported for the month of July.

**EMS Report:** Written report presented. The power load system/cots have been serviced by

Stryker on all three ambulances. A meeting has been requested with the Franciscan Alliance regarding Dyer/Munster bypassing ambulances to each

other's facilities.

Training Officer: Written report submitted. Members listed are working on completing

outstanding trainings.

**Grant Summary:** No word has been received on the outstanding grant award notifications.

Fire Prevention: Written report submitted. Fire Prevention Open House is scheduled for

September 24<sup>th</sup> from 10:00 am to 2:00 pm at Station #42. Work continues on

updating the fire codes.

## **Deputy Chief:**

Written report submitted. Currently the Kurtz contract has two vacancies. A meeting is scheduled for Tuesday, August 9<sup>th</sup> with Kurtz management to discuss vacancies on the contract and miscellaneous issues. One part-time applicant is being processed for hiring. Two POC applicants have failed the PAT; another test will be scheduled for early September. Discussion was had regarding the standards of the PAT, recent failures to pass the test and other options to consider. Chiefs questioned if the District should suspend the PAT requirement for a period of time due to the shortage of workers in the industry and what liability it creates for the department. Attorney Gilbert confirmed the PAT is not required legally for the hiring process. Trustees recommended the Chiefs discuss the issue further with all of the officers to determine whether a suspension of the test should be considered.

Contact has been made with members delinquent on monthly training. Accident and ambulance billing are current. Inspections will be scheduled as data entry is completed in the new fire reporting system. Hose testing is complete. Ladder testing is scheduled. Pump testing will be scheduled in the next thirty days. The application for reimbursement on the rechassis of Engine #43 through the American Rescue Plan is under review by Will County. The Firehouse database is now up and running on the CTFPD server. CTFPD has collected approximately \$56,000.00 from the GEMT program this year and is in the process of completing the 2023 program application. Reports were reviewed regarding a breakdown of calls, mutual aid to surrounding communities and response time to incidents.

### Chief's Report:

Written report was presented. Firefighter/Paramedic Visi has submitted a retirement letter from his part-time position but has asked to remain on the roster to continue coordinating CPR classes. This request will be discussed with the other officers. Notification was received from Will County Land Use Department an application has been submitted to utilize approximately 70 acres on Sawgrass Road for a vehicle training facility. The new ambulance chassis is expected to arrive next month at Foster Coach.

An estimate to crack fill and seal coat the driveway at Station #41 was presented for approval. Discussion was had on the maintenance of the driveway. Motion to accept the estimate from Roy Erikson Outdoor Maintenance Inc. to crack fill/seal coat the driveway at Station #41 in the amount of \$7,202.20 by Trustee Zimmerman. Second Trustee Miller. Motion carried. (3-yes, 0-no)
