

Written report presented - 145 calls were reported for the month of September.

**EMS Report:** 

Written report presented. Ambulance #41 has been taken to Foster Coach for the rechassis. The box has been removed from the old chassis and is being prepped for paint. Paint work on the new chassis will be complete in the next few days.

**Training Officer:** 

Written report submitted. Members listed are working on completing outstanding trainings.

**Grant Summary:** 

No word has been received on the outstanding grant award notifications.

**Fire Prevention:** 

Written report submitted. Balmoral Park is applying for a 107-day temporary permit for truck parking; the application for rezoning has been withdrawn.

**Deputy Chief:** 

Written report submitted. Ladder testing is scheduled. Accident and ambulance billing are current. An application for the 2023 GEMT program is in the process of being completed.

Chief's Report:

Written report was presented. Chief Panega reported POC member James Radtke has completed all requirements of the District and recommended District Trustees promote him to Firefighter/EMT status. Motion by Trustee Miller to promote POC member James Radtke from Probationary status to Firefighter/EMT status. Second Trustee Peterlin. Motion carried. (3-yes, 0-no)

CTFPD will begin participating in the Project Fire Buddies program. A check was received for the rental of the property behind Station #41 for the purpose of farming. Seventeen people attended the CPR Class on September 22<sup>nd</sup>. The audit for fiscal year ending April 30, 2022 is in the final stages of review. Plans have been received for two new solar fields, one on the

northwest corner of Cottage Grove and Munz and the second on Goodenow and Dutton. Previous discussion has been had regarding applicants struggling to pass the Physical Agility Test in the allotted time frame. Appendage 1, in the Rules & Regulations, already allows for adjustments to be made at the discretion of the Fire Chief without approval of the District Board. After much discussion with the Officers, Chief Panega stated the P.A.T. will go to a pass/fail requirement until further notice.

**Approval of Bills:**

Communications:

Beecher Fire Protection District – Thank You - A thank you was received from Beecher Fire Protection District for responding to a structure fire on Kedzie Avenue October 2<sup>nd</sup>.

**Old Business:** 

Pheasant Lake Estates Expansion – A meeting will be held at Will County November 4<sup>th</sup> regarding a hearing on the pre-application for an additional 433 units on the north and south side of Pheasant Lake Estates. Trustee Miller recommended Chief Panega compose a letter to the owners of the development requesting funds for a tornado siren and additional support vehicle due to the increase in calls the expansion will generate.

**Discuss / Approve Bathroom Renovation** – **Station #43** – A proposal from PBS, in the amount of \$158,893.00, was presented for the bathroom renovation at Station #43. Trustee Miller stated the project would have to go out for bid once CTFPD is ready to move forward with the work. After reviewing the proposal and the current budget, Trustees agreed the project will be tabled until next fiscal year.
