Old Business: Open & Discuss "Contract Service" Bid - Trustee Zimmerman opened and

read into record the following bids received for the Contract Service to

furnish six contract firefighter/paramedics:

Year #2 and #3 will be negotiated in good faith to determine costs.

Approve Revised Lawn Maintenance Proposal for the 2023 & 2024 Season – Roy Erikson Outdoor Maintenance Inc. – Motion by Trustee Miller to approve the addition to the original contract from Roy Erikson Outdoor Maintenance Inc. to include maintenance of the property west of Station #41 for an extra \$100.00 per month and a one-time fee of \$1,200.00 required to clean up the area and prepare for mowing.
